Olivier Kreiden

After graduating in medicine from the University of Basel, Switzerland, Dr Kreyden performed surgery for many years before he became a specialist in dermatology. During the years spent at the University Hospital of Zurich his area of expertise was the BTxA in the treatment of focal Hyperhidrosis. He founded and led the first centre in Switzerland for hyperhidrosis. In 2001, he opened his private Clinical Centre "Parxis" in MethininserhofMuttentz, near Basel, where dermato-cosmetic surgery and medicine is performed using botulinum toxin A, laser, IPL, peeling and mesotherapy. Dr. Kreiden has published numerous scientific works and is co-author of several books and book chapters in the field of Hyperhidrosis and in general for aesthetic medicine. Member of numerous international dermatological and aesthetic societies he regularly participates at conferences in the field worldwide as a speaker and as President. He founded, and is the current President, the Swiss group of Cosmetic Dermatology and skin care (SGEDS). Trainer in seminars and training courses for the use of BTxA and filler injections. In 2007 he received the prize "WhoisWho" – Award for his scientific work in dermatology and aesthetic medicine. In this book Dr. Kreyden gave his contribution regarding the treatment of Hyperhidrosis.

Dr. Braccini is a plastic surgeon specialized in facial surgery. He works in Nice, France, (ENT & FPS Istitute) and Paris, France (American Hospital of Paris). 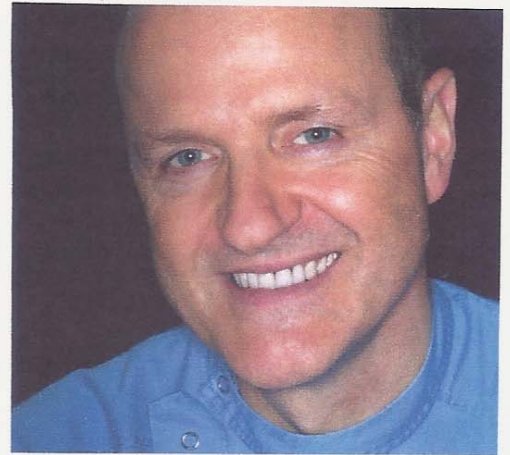
